

## CHRONOLOGY OF CHANGES TO THE IORC REVIEW LIST

(since 1 December 2012)

Note: when a species is added based on a first state record, the date listed here is the date that the record was accepted, rather than the date of the record itself.

### **Changes on 25 July 2024**

- The East St. Louis exception for Painted Bunting was removed.

### **Changes on 14 January 2024**

- The Siloam Springs State Park exception for Bewick's Wren was removed.

### **Changes on 9 January 2024**

- Broad-tailed Hummingbird was added (by virtue of a first accepted record of the species).

### **Changes on 6 July 2023**

- Western Flycatcher was added (by virtue of the lumping of Pacific-slope Flycatcher and Cordilleran Flycatcher in the 64th AOS supplement).

### **Changes on 18 April 2023**

- Crested Caracara was added (by virtue of a first accepted record of the species).

### **Changes on 14 January 2023**

- Evening Grosbeak was removed.

### **Changes on 9 November 2022**

- Painted Redstart was added (by virtue of a first accepted record of the species).

### **Changes on 26 July 2022**

- Brown Booby was added (by virtue of a first accepted record of the species).

### **Changes on 5 July 2022**

- Lesser Goldfinch was added (by virtue of a first accepted record of the species).

### **Changes on 19 March 2022**

- Little Gull was removed.
- Anhinga was removed for records from the southern tier of Illinois.
- Black Vulture was removed.
- Swallow-tailed Kite was removed.
- Barn Owl was removed.
- Townsend's Solitaire was removed.
- Hoary Redpoll was removed.

- White-winged Crossbill was removed.
- Western Tanager was removed.
- Painted Bunting was removed for records from the established breeding location in East St. Louis, St. Clair County.

#### **Changes on 29 June 2021**

- Mew Gull was replaced with Short-billed Gull (by virtue of taxonomic changes in the 62nd AOS Check-list Supplement and the evidence within prior accepted records under the former species name).

#### **Changes on 8 April 2021**

- Great Kiskadee was added (by virtue of a first accepted record of the species).

#### **Changes on 28 February 2021**

- White-winged Dove was removed.
- Neotropic Cormorant was removed.

#### **Changes on 2 March 2020**

- Small-billed Elaenia was added (by virtue of a first accepted record of the species).

#### **Changes on 20 February 2020**

- Black-bellied Whistling-Duck was removed.
- Gray Partridge was added.
- A note that " documentation should address why the record is thought to be from the naturally occurring population and not the migratory population whose introduction is being attempted" was added to the entry for Whooping Crane.
- Purple Sandpiper records from Lake Michigan were added.
- Evening Grosbeak was added.
- White-winged Crossbill was added.

#### **Changes on 2 February 2020**

- Limpkin was added (by virtue of a first accepted record of the species).
- Little Stint was added (by virtue of a first accepted record of the species).
- Cassin's Kingbird was added (by virtue of a first accepted record of the species).

#### **Changes on 27 August 2019**

- Lewis's Woodpecker was added (by virtue of a first accepted record of the species).

#### **Changes on 22 June 2019**

- Barnacle Goose was added (by virtue of a first accepted record of the species).

#### **Changes on 3 July 2018**

- Plumbeous Vireo was added (by virtue of a first accepted record of the species).

### **Changes on 14 May 2018**

- Red-naped Sapsucker was added (by virtue of a first accepted record of the species).
- Cassin's Vireo was added (by virtue of a first accepted record of the species).

### **Changes on 12 February 2017**

- Non-adult California Gull was removed (completely removing California Gull from the Review List).
- Pacific Loon was added.
- Tricolored Heron was added.

### **Changes on 22 January 2017**

- Common Ringed Plover was added (by virtue of a first accepted record of the species).

### **Changes on 6 July 2016**

- Green Violetear was replaced with Mexican Violetear (by virtue of taxonomic changes in the 58th AOS Check-list Supplement and the evidence within prior accepted records under the former species name).
- Western Scrub-Jay was removed (by virtue of taxonomic changes in the 58th AOS Check-list Supplement and the evidence within prior accepted records under the former species name).

### **Changes on 12 January 2014**

- Swainson's Hawk was removed.
- California Gull was added for records involving non-adult birds.
- Bewick's Wren was removed for records from Siloam Springs State Park.
- Painted Bunting was added for records from East St. Louis (so that all records are on the Review List).

### **Changes on 1 December 2012**

- Wandering Tattler was added (by virtue of a first accepted record of the species group).
- Western Gull was removed (by virtue of the sole accepted record being reconsidered and rejected).

### **Changes with the 4th IORC report (published 1998)<sup>1</sup>**

- Red-throated Loon was removed.
- Red-necked Grebe was removed.
- Western Grebe was removed.
- Yellow Rail was removed.
- Black-necked Stilt was removed.
- Red Phalarope was removed.

<sup>1</sup> The report notes that "Eleven species have been removed since the last published review list," citing the 3rd IORC report for that published list. Thirteen species were listed, though Spotted Towhee was noted as not being on any published Review List.

- Little Gull was removed.
- Iceland Gull was removed. (At the time, Iceland Gull referenced *Larus glaucopterus kumlienii/glaucoides*)
- Lesser Black-backed Gull was removed.
- Black-legged Kittiwake was removed.
- Sabine's Gull was removed.
- Western Kingbird was removed.
- Spotted Towhee was formally removed, although its presence on the Review List was informal.
