1990-2021 REPORT OF THE

KANSAS BIRD RECORDS COMMITTEE

This report summarizes records received and evaluated by the Committee for the calendar years 1990-2019. A total of 1,183 submissions were received by the Committee during the period, 887 were circulated for evaluation, and 707 were accepted. Record submissions are assigned a sequential number in the order in which they are received with the year (of receipt) as a prefix. Not all submissions that receive a number are circulated. Birds are listed in phylogenetic order under each of two categories: Records Accepted and Records Not Accepted. Taxonomy and nomenclature follow the American Ornithological Society's Check-list of North American Birds, Seventh Edition (A.O.U. 1998) and all subsequent supplements.

The KBRC record number follows the scientific name, with the number of individuals seen, date(s) of observation, locality, observer(s) documenting the record, any supporting physical evidence, and any significant change in status. Rejected records have the observer(s) names omitted and a brief explanation as to the reason for rejection. Additional information on each record can be found in each year's report on the <u>KBRC homepage</u>.

Species names in brackets [] are hypothetical in that they have not been verified with physical evidence, i.e. photo, video/audio recording, specimen, recovered band, etc.

Fulvous Whistling-Duck (Dendrocygna bicolor)

2007-21; one adult, 26 June 2007, Quivira NWR, Stafford County, reported by Matt Gearheart, also seen by Aaron Mitchell and Terry Swope. Documented with four photographs. This is the first confirmed record of this species in the state in over 20 years.

Taiga Bean Goose/Tundra Bean Goose, (Anser fabalis/Anser serrirostris)

2014-01; one unknown age, 25 January 2014, Minooka Point, Wilson Lake, Russell County, reported by Robert Penner and Mike Rader, submitted with drawing. This record was originally submitted as a Taiga Bean Goose and not accepted by the KBRC based on insufficient details to separate it from Tundra Bean Goose. Upon re-evaluation by the KBRC it was felt that the record should be accepted at the Taiga Bean Goose (*Anser fabilis*)/Tundra Bean Goose (*Anser serrirostris*) complex level as sufficient details were submitted to confirm that it was one of the two species based on visual description, call description, and the drawing by Penner. This is the first record of either of these species and will be added to the KOS Check-list as a hypothetical species.

Brant (Branta bernicla)

Cackling Goose (Branta hutchinsii)

While Kansas specimens for this species are present in the KU Collection, this is the first non specimen state record.

RECORDS NOT ACCEPTED

Bar-headed Goose (Anser indicus)

2019-07; one adult, 20 April 2019, Neosho Wildlife Area, Neosho County. Identification of the bird was not in question. The record was not accepted due to unknown provenance of the bird. Bar-headed Goose is not on the American Ornithologists Society checklist of North American Birds. Even though this bird is routinely kept by zoos and waterfowl fanciers, the bird appeared fairly wild and the KBRC requested that this sighting be submitted so that a record of its occurrence could be maintained. Bar-headed Goose breeds in central Asia and winters in southern Asia. A feral population is apparently well established in northern Europe.

Mute Swan (Cygnus olor)

99-09; 1 adult; 21 March 1999; Evans Creek arm of Perry Lake, Jefferson Co; Origin questionable. This species is commonly kept in captivity, and there are several waterfowl fanciers in the Perry Lake area who keep Mute Swans.

Trumpeter Swan (Cygnus buccinator)

Garganey (Spatula querquedula)

Falcated Duck (Mareca falcata)

2004-01; 1 adult male, 1 January 2004, at a pond in Topeka (Shawnee County). Insufficient details to rule out other Anas species and given the rarity of this species in North America, origin of the bird would have to be questioned.

Tufted Duck (Aythya fuligula)

Clark's Grebe (Aechmophorus clarkii)

Blue-throated Mountain-Gem (Lampornis clemenciae)

- **2007-06**; one immature female, 1 September-3 September 2006, Wichita, Sedgwick County. Insufficient details to separate from a female Ruby-throated Hummingbird. Photographs not conclusive.

Rufous Hummingbird (Selasphorus rufus)

2002-41; 1 unknown age/female from 8-Sep-2001 through 13-Sep-2001, backyard in Wichita (Sedgwick County). The description provided for this report did not provide enough detail to rule out the possibility of other *Selasphorus* species.

Broad-tailed Hummingbird (Selasphorus platycercus)

96-19; 1; 20 May 1996; St. John, Stafford Co; Identification questionable, insufficient details to eliminate similar species.

98-01; 1 adult female, 20-30 August 1997; Larned, Pawnee Co; 2 photos. This record was voted on, but was recirculated and was ultimately determined to be either a Allen's Hummingbird (*Selasphorus sasin*) or a Rufous Hummingbird (*Selasphorus rufus*), but not a Broad-tailed Hummingbird. Record was rejected on the second vote.

White-eared Hummingbird (Hylocharis leucotis)

2010-14: one adult female, 3 September 2005, Wichita backyard (Sedgwick County). A photo obtained of a distant hummingbird became so grainy and blurry upon enlargement that the Committee felt it could not accept this potential first state record based on the photograph obtained. The written report is mainly based on interpretation of the photograph and does not eliminate all other possibilities.

Wilson's Plover (Charadrius wilsonia)

2014-25; three of unknown age and gender, 10 July 2014, Quivira National Wildlife Refuge, Stafford County. The details provided did not eliminate other similar species of plover.

Red Knot (Calidris canutus)

2000-39; 1; 13 May 2000; marsh north of Red Bud Acres, Riley Co; Identification questionable; insufficient details to eliminate similar species.

Ruff (Calidris pugnax)

- **2013-20**; juvenile female, 13 October 2013, Big Salt Marsh, Quivira NWR, Stafford County. The details and photos provided did not eliminate other Calidris sandpipers that could be confused with a Ruff.
- **2015-33**; 1 adult of unknown gender, 29 August 2015, Elk City Lake, Montgomery County, accompanied by one photograph. Insufficient details to separate from other *Calidris* sandpipers.

Spoon-billed Sandpiper (Calidris pygmea)

99-50; 1 in basic plumage, 27 April 1999; Cheyenne Bottoms, Barton Co; Identification questionable, insufficient details to eliminate other similar species.

White-rumped Sandpiper (Calidris fuscicollis)

- **2012-27**; 15 to 17 of unknown gender, 25 August 2012, Kansas State University Beef Cattle Research Center lagoon, Manhattan, Kansas; Riley County. The details provided did not eliminate similar appearing shorebirds.
- **2012-35**; one of unknown age and gender in alternate plumage, 4 July 2012, Quivira National Wildlife Refuge, Stafford County. The details provided did not eliminate similar appearing shorebirds.

Pomarine Jaeger (Stercorarius pomarinus)

98-11; 1; 9 December 1997; Sundance area, Melvern Reservoir, Coffey Co; Identification questionable, insufficient details to eliminate other similar species

Parasitic Jaeger (Stercorarius parasiticus)

92-17; 2; 31 August 1985; Cheyenne Bottoms Wildlife Area, Barton Co; Identification questionable; insufficient details to eliminate similar species.

Long-tailed Jaeger (Stercorarius longicaudus)

- **92-16**; 1; 31 August 1985; Cheyenne Bottoms Wildlife Area, Barton Co; Identification questionable; insufficient details to eliminate similar species.
- **2003-64**; 1 immature/unknown sex, 9 November 2003 at Quivira NWR's Big Salt Marsh, Stafford County. The brief duration of sighting did not provide the viewer with adequate time to rule out other jaeger species.

Long-billed Murrelet (Brachyramphus perdix)

2011-24; adult in breeding or possible transition plumage, 25 November, 2011, Cedar Bluff Reservoir, Trego County. The brief views of an actively diving bird and the details provided did not rule out all other possible species for the Committee to accept this record.

"Alcid"

2007-35; one unknown age, 23 November 2007, Lake Wabaunsee, Wabaunsee County. While most committee members were intrigued by the description given for this bird, all felt it was insufficient to differentiate which species it might be or if it was in fact an alcid.

Black-legged Kittiwake (Rissa tridactyla)

- **92-02**; 1; 28 December 1991; Lake Olathe, Johnson Co; Identification questionable; insufficient details to eliminate similar species.
- **2001-54**; 10 adults; 3 November 2001; near Perry Lake Dam, Jefferson Co; Identification questionable; insufficient details to eliminate similar species.
- **2013-02;** immature of unknown gender, 2 February 2012, Perry Reservoir, Jefferson County. The details provided did not eliminate other similar gulls.
- **2013-08**; immature of unknown gender, 4 September 1995, Quivira NWR, Big Salt Marsh along NE 170 St., Stafford County. The details provided did not eliminate other similar gulls.

Black-headed Gull (*Chroicocephalus ridibundus*)

91-39; 1; 29 November 1991; Milford Lake, Geary Co; Identification questionable; insufficient details to eliminate similar species.

Short-billed Gull (*Larus brachyrhynchus*)

- **91-40**; 1; 7 December 1991; John Redmond Reservoir, Coffey Co; Identification questionable; insufficient details to eliminate similar species.
- **92-05**; 1; 4 December 1991; Tuttle Creek Reservoir. Riley and Pottawatomie Co; Identification questionable; insufficient details to eliminate similar species.
- **2000-13**; 1; 9 February 2000; Shawnee Mission Park, Johnson Co; Identification questionable; insufficient details to eliminate similar species, including atypical plumages of Ring-billed Gull (*Larus delawarensis*).
- **2015-32**; 1 adult, 18 November 2014, Sandpit near Hutchinson, Reno County. Description and photographs did not rule out similar gull species.

- **2018-35**; one sub-adult, 12 January 2017, John Redmond Reservoir, Coffey County. Insufficient details to eliminate similar gull species.
- **2021-03**; one immature, 28 January 2021, at Clinton Lake, Douglas County. Insufficient details to separate this bird from a Ring-billed Gull.

Western Gull (Larus occidentalis)

2000-47; 1; 1 March 2000; sandpit at 29th St. N and West St., Wichita, Sedgwick Co; Identification questionable; insufficient details to eliminate similar species.

Iceland Gull (*Larus glaucoides*) (Including the previously separate species, Thayer's Gull)

- **95-08**; 1; 11-13 December 1994; near Wichita, Sedgwick Co; Identification questionable, insufficient details to eliminate Thayer's Gull.
- **2000-09**; 1; 24 January-12 February 2000; various spots in west Wichita, landfill, K96 bridge etc., Sedgwick Co; Identification questionable; insufficient details to eliminate similar species. Accompanying video and the written report contained inconsistencies which did not match up well.
- **2001-57**; 1 immature, 26-28 November 2001; Melvern Lake outlet park, Osage Co; Although extensively documented with photographs, insufficient details to eliminate other species such as Thayer's Gull, or a hybrid.
- **2002-5**; 1 immature basic plumage, 23 February 2002, outlet area of John Redmond Reservoir (Coffey County). Identification of immature gulls in this species complex is difficult, and the description provided did not provide enough detail to rule out other possible identifications.

Lesser Black-backed Gull (*Larus fuscus*)

- **95-04**; 1; 8 January 1995; Hillsdale Lake, Miami Co; Identification questionable, insufficient details to eliminate Herring Gull.
- **96-12**; 1; 26 December 1996; Tuttle Creek Reservoir, Pottawatomie Co; Identification questionable, insufficient details to eliminate similar species.
- **2001-11**; 1 adult in winter plumage, 11 February 2001; sandpit lake at corner of 29th and West St in Wichita, Sedgwick Co; Identification questionable, insufficient details to eliminate similar species.
- **2001-12**; 1 adult; 19 February 2001; El Dorado Lake, Butler Co;. Identification questionable, insufficient details to eliminate similar species.

Slaty-backed Gull (*Larus schistisagus*)

2014-04; adult in winter plumage of unknown gender, 2 February 2014, Cheney Reservoir, Reno County. The details and photographs did not eliminate other similar gull species.

Glaucous-winged Gull (Larus glaucescens)

2000-10;1; 12 February 2000; landfill in Wichita, Sedgwick Co; . Identification questionable; insufficient details to eliminate similar species.

Great Black-backed Gull (Larus marinus)

- **2008-29;**, one adult, 19 November 2008, Cheyenne Bottoms Wildlife Management Area, Barton County. Insufficient details to separate this species from similar species.
- **2013-05**; winter adult of unknown gender 12 January 2013, Winfield City Lake, Cowley County. The details provided did not eliminate other large dark backed gulls.

Red-throated Loon (Gavia stellata)

98-08; 25 October 1997; dam area, Clinton Reservoir, Douglas Co; Identification uncertain, insufficient details to eliminate other species.

Arctic Loon (Gavia arctica)

2008-26; one unknown age, 10 October 2008, Perry Lake, Jefferson County. Insufficient details to separate from Common Loon or Pacific Loon.

Yellow-billed Loon (Gavia adamsii)

- **91-25**; 1; 17 November 1990; Winfield City Lake, Cowley Co; Identification questionable; insufficient details to eliminate Common Loon.
- **2012-33**; one adult in breeding plumage of unknown gender, 25 October 2012, small pond east of Emporia, Lyon County. The details provided did not eliminate other loon species.

Band-rumped Storm Petrel (Hydrobates castro)

2005-07; four birds observed on 18 July 2005 at Meade State Lake (Meade County). Insufficient details to separate from similar species.

Magnificent Frigatebird (Fregata magnificens)

- **97-35**; 1 individual; 28 July 1997; Tuttle Creek Reservoir, Riley Co; Identification questionable; description of the bird was sketchy and had insufficient details to eliminate other large soaring species.
- **2010-07**; one adult female in basic plumage, 1 April 2010, north of Bushton (Ellsworth County). A sighting of short duration with insufficient details provided to separate from a cormorant.

Anhinga (Anhinga anhinga)

- **2010-07**; one adult female in basic plumage, 1 April 2010, north of Bushton (Ellsworth County). A sighting of short duration with insufficient details provided to separate from a cormorant.
- **2015-17**; one of unknown age, 13 May 2015, in flight near Kansas River, Johnson County. Details provided did not rule out any cormorant species.
- **2018-33**; one unknown age, 21 October 2018, Bone Creek Reservoir, Crawford County. Insufficient details to separate from either cormorant species.

Great Blue Heron, white morph (Ardea herodias)

2007-13; one adult, 14 April 2007 at a farm pond in Johnson County. Insufficient details to separate from Great Egret.

Glossy Ibis (Plegadis falcinellus)

2012-10; 14 of unknown age and gender, 28 April 2012, Horsethief Reservoir, Hodgeman County. The details necessary to separate the *Plegadis* species are not provided. The birds identifiable in the documenting photograph are White-faced Ibis (*Plegadis chihi*).

Black Vulture (*Coragyps atratus*)

- **2000-48**; 2; 13 May 2000; levee trail along Kansas River, Manhattan, Riley Co; This fascinating report was accompanied by 2 photos which depicted a bird structurally (tail and head proportions) identical to turkey vulture (*Cathartes aura*), with dark wings having lighter patches in the primaries similar to Black Vulture. Based on the structure of the bird, it was concluded that these two birds were melanistic Turkey Vultures.
- **2001-25**; 3 individuals; 12 May 2001; Ford Co; Description was consistent with an identification of Turkey Vulture.

White-tailed Kite (Elanus leucurus)

- **2012-15**; 29 May 2012, one adult, Clinton State Park, Douglas County. The short duration of the sighting and the details provided did not eliminate other species that could be confused with White-tailed Kite.
- **2013-9;** adult of unknown gender, 17 February 2014, approximately two miles north of Princeton on highway 59 south, Franklin County. The brief duration of the sighting and the details provided did not eliminate other potential species.

Swallow-tailed Kite (*Elanoides forficatus*)

2018–20; one unknown age, 14 August 2018, Sandhills State Park, Reno County. Insufficient details to separate from other kite species.

Golden Eagle, (Aquila chrysaetos)

2006–03; one unknown age, 10-11 April 2006, observed in a Wichita residential back yard (Sedgwick County). Based on photographs submitted with the record the bird appeared to be a *Buteo*, probably a dark phase Red-tailed Hawk.

Northern Goshawk (Accipiter gentilis)

- **2016-07;** adult, 6 January 2015, Ft. Riley training area, Geary County. Insufficient details to separate from other accipiter species.
- **2017-04**; adult, 9 January 2017, Cheney State Park, Reno County. Insufficient details to separate from other accipiter species.

Common Black-Hawk (Buteogallus anthracinus)

2011-07; after hatch year immature, 10 April, 2011, at a shelterbelt near Elkhart, Morton County (see details of sighting in Raynor, E. J., T. T. Cable, and D. Wiggins, 2011. Common Black-Hawk: A Probable Kansas Record and Recent Range Expansion in the Southwestern U.S. Kansas Ornith. Soc. Bull. 62[4]:33-41). The report of this potential first state record contained too many generalizations and not enough detail of the plumage to eliminate all other possible juvenile raptors.

Red-shouldered hawk (Buteo lineatus)

2000-22; 1; 20 April 2000; ½ mile east of Artesian Corrals, Cimarron National Grassland, Morton Co; Identification questionable; insufficient details to eliminate similar species.

Swainson's Hawk (Buteo swainsoni)

2007-07; one adult, 5 February 2007, near Cheyenne Bottoms Wildlife Management Area, Barton County. Insufficient details to confirm that this wasn't another *Buteo* species.

Western Screech-Owl (Megascops kennicottii)

- **91-15**; 2; 9 April 1991; Along the Cimarron River, Morton Co; Identification questionable, insufficient details to eliminate Eastern Screech-Owl.
- **99-38**; 1; 4 September 1999; Wilburton Crossing on the Cimarron River, Morton Co; Identification questionable. The bird was heard only and not seen. An Eastern Screech-Owl (*Megascops asio*) was observed in the same location a week later that was heard doing an unusual "western-sounding" call

Snowy Owl ((Bubo scandiacus))

2015-10; 1 male of unknown age, 11 April 2015, Overland Park residence, Johnson County. Details provided did not rule out leucestic/albinistic hawk or large owl species.

Ringed Kingfisher (Ceryle torquata)

99-36; 1 adult male; 14 August 1999; Cheyenne Bottoms, Barton Co; Identification questionable, insufficient details to eliminate Belted Kingfisher (*Ceryle alcyon*).

Golden-fronted Woodpecker, (Melanerpes aurifrons)

2006-30; one adult male, spring 2005, observed at a rural residence in Brown County. Insufficient details to separate from Red-bellied Woodpecker.

Ladder-backed Woodpecker (*Dryobates scalaris*)

2017-03; adult male, 1 December 2016 to 8 January 2017, backyard feeder in Cawker City, Mitchell County. Photograph submitted with the record appeared to be of a different woodpecker species.

Crested Caracara (Caracara plancus)

- **2003-47**; 1 subadult/unknown sex, 24 June 03, along I-35 in Johnson County. This species is not currently on the Kansas checklist. The brief duration of the sighting and the distance from the bird did not allow adequate time to rule out other possible species and confirm identification.
- **2021-08**; one adult, 5 May 2021, alongside a road in Rice County. Insufficient details to separate this bird from other raptors.

Gyrfalcon (Falco rusticolus)

- **95-06**; 1; 21 December 1994; Geary Co; Identification questionable; insufficient details to eliminate similar species.
- **2020-40**; 1 unknown age, 2 December 2020 from McPherson State Fishing Lake, McPherson County. Insufficient details to separate this bird from other falcon species.

Ash-throated Flycatcher (*Myiarchus cinerascens*)

- **90-05**; 1; 30 September 1990; Miami Co; Identification questionable; insufficient details to eliminate similar species.
- **98-56**; 1; 14 October 1998; 3 mi. E of Tonganoxie, Leavenworth Co; Identification questionable, insufficient details to eliminate other similar species

Couch's Kingbird (Tyrannis couchii)

2021-19; one of unknown age, 27-30 November 2021, near Lyon State Fishing Lake, Lyon County. Viewed by numerous observers, included many photographs and video. Many of the photos showed outside tail feathers with lateral white edges, which are inconsistent with a Couch's Kingbird. Vocal recordings are not consistent with expected vocalizations of a Western Kingbird (*Tyrannis verticalis*). The bill appeared smaller than what a Couch's Kingbird should have. Based on the physical evidence, and discussions with experienced ornithologists, if was felt that the data presented was inconclusive as to its parentage and could not rule out a hybrid.

Olive-sided Flycatcher (Contopus cooperi)

98-52; 1 adult; 9 & 30 June 1998; Walla Walla Rd, west of Junction City, Geary Co; Identification questionable, insufficient details to eliminate other flycatcher species

Hammond's Flycatcher (Empidonax hammondii)

- **97-41**; 1; 20-21 September 1997; Elkhart, Morton Co; Identification questionable, insufficient details to conclusively eliminate other species of *Empidonax* flycatchers.
- **2001-45**; 1 in fall plumage;15 September 2001;USFS Work Station, Cimarron National Grassland, Morton Co; Identification questionable, insufficient details to conclusively eliminate other species of *Empidonax* flycatchers.
- **2015-02**; 1 of unknown age or gender, 1 September 2014, Clark State Fishing Lake, Clark County. Insufficient details to separate from other *Empidonax* flycatchers. *Empidonax* flycatchers in the fall are notoriously difficult to differentiate.

Gray Flycatcher (*Empidonax wrightii*)

- **2001-37**; 2 adults; 1-2 September 2001; Cimarron National Grasslands, Morton Co; Identification questionable, insufficient details to conclusively eliminate other species of *Empidonax* flycatchers.
- **2001-46**; 1 adult; 15 September 2001; Middle Spring, Cimarron National Grassland, Morton Co; Identification questionable, insufficient details to conclusively eliminate other species of *Empidonax* flycatchers.
- **2013-16;** unknown gender and age, 1 September 2013, Elkhart Cemetery, Morton County. The details necessary to eliminate other Empidonax flycatchers were not noted on this bird.

Cordilleran Flycatcher (*Empidonax occidentalis*)

- **92-18**; 1; 5 September 1993; Cimarron River, Morton Co; Identification questionable; insufficient details to eliminate similar species.
- **2004-33**; 1 adult, 5 September 2004 at Middle Spring in the Cimarron National Grasslands (Morton County). Insufficient details to separate from other Empidonax flycatchers.

2004-35; 1 unknown age, 18 September 2004, observed in Garden City (Finney County). Insufficient details to separate from other Empidonax flycatchers.

Black Phoebe (Sayornis nigricans)

2009-29; one juvenile/immature of unknown gender, 13 September 2009, Cimarron National Grasslands, Cottonwood Picnic Grounds (Morton County), Although the committee felt this could have been a Black Phoebe insufficient details were provided to separate from a possible hybrid phoebe. Several Eastern x Black Phoebe hybrids have been found in nearby states.

Cassin's Vireo (Vireo cassinii)

- **99-23**; 1 adult; 7 May 1999; south side of Tuttle Creek River Pond, Pottawatomie Co; Identification questionable, insufficient details to eliminate Blue-headed Vireo (*Vireo solitarius*).
- **2004-36**; 1 adult, 4 September 2004 observed in the Elkhart sewer ponds shelterbelt (Morton County). Insufficient details to separate from Blue-headed Vireo.
- **2009-26**; 19-20 September 2009, Maple Grove Cemetery, Wichita (Sedgwick County). This is one of the difficult identification challenges in Kansas. Light colored female or immature Blue-headed Vireos can look identical to Cassin's Vireos in the field. The age of the bird must be taken into account for an accurate ID. This record was originally accepted by the committee. After a lengthy discussion it was decided that there was insufficient data to accept this record.
- **2014-15**; adult of unknown gender, 5 May 2014, Elkhart cemetery, Morton County, documented with photographs. The details and photographs did not eliminate the extremely similar Blue-headed Vireo. (This record was resubmitted as **KBRC** # **2018-29**, with additional supporting evidence and accepted.)
- **2014-16**; one of unknown age and gender, 3 May 2014, Elkhart shelterbelt, Morton County, documented with photographs. The details and photographs did not eliminate the extremely similar Blueheaded Vireo.
- **2016-36**; unknown age, 11 September 2016, St. Francis Golf Course, Cheyenne County. Insufficient details to differentiate from very similar Blue-headed Vireo, especially in this time period.
- **2019-18**; 21 May 2019, one adult, Ford County State Fishing Lake, Ford County. Insufficient details to separate from Blue-headed Vireo.
- **2020-26**; 1 unknown age, 11 September 2020 from the Elkhart shelterbelt, Morton County. Insufficient details to separate this bird from Blue-headed Vireo.
- **2020-28;** 1 unknown age, 13 September 2020 from Middle Springs, Cimarron National Grassland, Morton County. Insufficient details to separate this bird from Blue-headed Vireo.

Canada Jay (Perisoreus canadensis)

2017-28; 30 December 2017, Rural residence near Lyons, Rice County. Insufficient details to confirm identification of a species strongly tied to coniferous forests and not prone to vagrancy.

Chihuahuan Raven (Corvus cryptoleucus)

2008-23; one unknown age, 25 August 2008, near the Stockdale Park area of Tuttle Creek Reservoir, Riley County. Submitted with two photographs. Insufficient details to separate this bird from an American Crow.

2016-18; 4 January 2015, Middle Springs, Cimarron National Grasslands, Morton County. Insufficient details to separate from Common Raven.

Common Raven (Corvus corax)

- **2019-30**; 30 August 2019, one unknown age, Cimarron National Grasslands north of Elkhart, Morton County. Insufficient details to separate from Chihuahuan Raven.
- **2019-23**; 31 August 2019, two unknown age, Middle Springs area of Cimarron National Grasslands, Morton County. Insufficient details to separate from Chihuahuan Raven.

Black-crested Titmouse (Baeolophus atricristatus)

2016-23; two adult males, 29 May 2016, heavily wooded suburban yard on the edge of Pittsburg, Cherokee County. Insufficient details to separate from other titmouse species.

Violet-green Swallow (Tachycineta thalassina)

- **2000-62**; 1; 6 September 2000; Cheyenne Bottoms WA, Barton Co; Identification questionable, insufficient details to eliminate similar species.
- **2004-37**; 5 possible juveniles, 2 October 2004, observed in Blue Rapids (Marshall County). Insufficient details to separate from other Tree Swallow.
- **2009-11**; one immature, 14 May 2009, Shawnee Mission Park (Johnson County). Insufficient details were provided to separate from similar Tree Swallow. The committee discussed the necessity of care in identification of western species in the eastern parts of the state with this record.

Cave Swallow (Petrochelidon fulva)

- **2014-17;** juvenile/immature of unknown gender, 21 June 2014, just east of Boicourt on the bridge over the river, Linn County. The details provided did not eliminate similar swallows.
- **2014-21;** juvenile/immature, 21 June 2014, approximately five miles south of the LaCygne power plant, Linn County. The details and photograph did not eliminate the similar Cliff Swallow.
- **2016-47**; immature, 16 October 2016, John Redmond Reservoir, Coffey County. Insufficient details to separate from Cliff Swallow.

Phainopepla (Phainopepla nitens)

2007-09; one adult, 16 February 2007, at a feeder near Oskaloosa, Jefferson County. Insufficient details to separate from other species that may have a crest. The observation was very short in duration and the time of year is not when this species would be expected to be seen in Kansas. Additionally, this bird was seen at a feeder which is atypical for this species.

Canyon Wren (Catherpes mexicanus)

2014-19; adult of unknown gender, 26 March 2014, Point of Rocks in the Cimmaron National Grasslands, Morton County. The details provided did not eliminate other similar wren species.

Sage Thrasher (*Oreoscoptes montanus*)

2013-11; unknown age and gender, 9 September 1997, Lucas Park Recreation Area along Sand Road, Russell County. Details provided are minimal for a sixteen-year-old sighting with no field notes.

Long-billed Thrasher (*Toxostoma longirostre*)

2000-37;1; 2 June 2000; shelterbelt north of Elkhart Cemetery, Morton Co; Identification questionable, insufficient details to eliminate similar species.

Western Bluebird (Sialia mexicana)

- **2005-04**; one male, 9 May 2005 in suburban Wichita (Sedgwick County). Insufficient details to separate from Eastern Bluebird.
- **2008-32**; one adult male, 23 October 2008, in Barber County. Insufficient details to separate this bird from the similar Eastern Bluebird.
- **2018-01;** one adult male, 1 January 2018, near Medicine Lodge, Barber County. Insufficient details to separate from other bluebird species.

Bicknell's Thrush (Catharus bicknelli)

2019-11; 16 May 2019, one adult, River Pond State Park, Manhattan, Riley County. Insufficient details to confirm identity of a species significantly out of range which has a well-documented limited range and virtually no vagrancy west of the Appalachian Mountains.

Northern Wheatear (Oenanthe oenanthe)

95-35; 1; 7 November 1995; Ottawa Co.; Identification questionable, insufficient details to eliminate similar species.

Yellow Wagtail (Motacilla flava)

99-45; 7 birds, in a family group, exact date not submitted, presumably summer of 1998, rural area west of Topeka, Shawnee Co; Identification questionable. Photographs submitted with the report indicated that these birds were probably Western Kingbirds (*Tyrannus verticalis*).

Eastern Yellow Wagtail (Motacilla tschutschensis)

2008-06; one unknown age, 13 January 2004, in northeastern Garden City, Finney County, submitted with photographs and video. Insufficient details to confirm identification of this bird.

Lesser Goldfinch (Spinus psaltria)

- **91-10**; 1; 2 April-15 May 1991; Garden City, Finney Co; photos. Identification questionable; insufficient details to eliminate American Goldfinch.
- **2010-01**; one adult, 2 January 2010, about four miles northwest of Medicine Lodge (Barber County). A short duration of the sighting and insufficient details to separate from similar species.
- **2014-13**; adult in definitive plumage, 18 May 2014, backyard thistle feeder, Pratt County. The details provided did not eliminate other similar species.
- **2014-14;** adult in definitive plumage, 12 May 2014, farmyard south of Wilson, near the Smoky Hill River, Russell County. The details provided did not eliminate other similar species.

Bachman's Sparrow (Peucaea aestivalis)

99-27; 2 adults, 28 May 1999; Bronco Road, Chautauqua Co; Identification questionable, insufficient details to eliminate similar species.

Black-throated Sparrow (Amphispiza bilineata)

2019-24; one immature, 14 September 2019, western crossing of the Cimarron River, Cimarron National Grasslands, Morton County. Photo and details were insufficient to confirm the identification of the bird.

Black-chinned Sparrow (Spizella atrogularis)

93-06; 2; 6 May 1990; Cimarron River, Morton Co; Identification questionable; insufficient details to eliminate similar species.

White-throated Sparrow (Zonotrichia albicollis)

2012-22; 12 June 2012, one singing, Cedar Niles Park, 127th and Cedar Creek Bridge, Johnson County. The documentation of song and spectrograms did not eliminate similar sounding species.

Sagebrush Sparrow (Artemisiospiza nevadensis)

95-02; 2; 2 January 1995; near Liberal, Seward Co; Identification questionable, insufficient details to eliminate similar species.

Henslow's Sparrow (Centronyx henslowii)

99-51; 1; 18 December 1999; Near Zeandale, Riley Co; After two voting rounds, this record was rejected. Identification questionable; insufficient details to eliminate similar species.

Canyon Towhee (Melozone fuscus)

2007-14; one adult, 7 May 2007, Monument Rocks, Gove County. Description given was insufficient to adequately confirm that the bird seen was this species.

Bullock's Oriole (Icterus bullockii)

2012-37; 19 May 2012, one first year male, Wyandotte County Lake Park, behind the Schlagle Library, Wyandotte County, documented with one photo. The head on photo does not eliminate a possible older female Baltimore Oriole.

Scott's Oriole (*Icterus parisorum*)

94-11; 1; 27 May 1994; Elkhart, Morton Co; Identification questionable; insufficient details to eliminate Northern Oriole.

Shinv Cowbird (*Molothrus bonariensis*)

- **2016-11**; adult female, 24 April 2016, urban backyard birdfeeder, Johnson County. Insufficient details to separate from other cowbird species.
- **2020-30;** 1 adult male, 21 October 2020, from a residential area of Olathe, Johnson County. Insufficient details to separate this bird from a Brown-headed Cowbird.

Swainson's Warbler (*Limnothlypis swainsonii*)

2009-10; one unknown age/sex, 10 May 2009, Ford County Fishing Lake Refuge (Ford County). Insufficient description was given to separate from another similar species.

2014-30; one of unknown age and gender, 22 September 14, 7800 W. 110th St. Overland Park, KS 66210, Johnson County. The details and photograph did not rule out similar looking species.

Nashville Warbler (Leiothlypis ruficapilla)

2018-34; one adult male, 28 November 2018, Wichita residence, Sedgwick County. Insufficient details to separate from other warbler species or kinglets.

Virginia's Warbler (Leiothlypis virginiae)

- **2001-40**; 1 adult female in basic plumage; 1 September 2001; Boy Scout area, Cimarron National Grassland, Morton Co; Identification questionable, insufficient details to eliminate similar species.
- **2015-15**; adult male, 6 May 2015, Wichita State University Campus, Sedgwick County. Details provided did not rule out similar warbler species.

Connecticut Warbler (*Oporornis agilis*)

- **2001-48**; 1 adult female in basic plumage; 24 September 2001; Swansons Park in Wichita, Sedgwick Co; Identification questionable, insufficient details to eliminate similar species.
- **2016-15**; adult male, 13 May 2013, Burcham Park, Lawrence, Douglas County. Insufficient details to separate from other similar warbler species.
- **2017-18**; adult male, 12 September 2017, Residential area, Berryton, Shawnee County. Insufficient details to separate from similar warbler species.

Blackpoll Warbler (Setophaga striata)

2016-41; unknown age, 16 October 2016, Lake Parsons, Neosho County. Fall Blackpoll Warblers, along with Pine and Bay-breasted Warblers, make for a complex that is difficult to separate in the field. The description provided did not provide adequate details to confirm the identification.

Grace's Warbler (Setophaga graciae)

92-54; 1; 12 September 1992; Point of Rocks, Morton Co; Identification questionable, insufficient details to eliminate similar species.

Hepatic Tanager (Piranga flava)

- **2012-18;** 5 July 2012, one adult male, in a backyard on 7000 block of Kimberly, Johnson County. The report has minimal details and does not eliminate any of the other *Piranga* species seen in Kansas.
- **2018-09**; one adult male, 7 May 2018, shelterbelt north of the Elkhart Cemetery, Morton County. Insufficient details to separate from Summer Tanager.

Blue Bunting (Cyanocompsa parellina)

2007-30; one adult female, 12 September 2007, in riparian woods near Kansas River, Johnson County. Insufficient details to separate from female or immature Indigo Bunting.

Yellow-faced Grassquit (*Tiaris olivaceus*)

2013-15; adult female, 14 July 2013, back yard in Olathe, Johnson County. The details provided do not eliminate other small bunting type birds that could create confusion. Provenance was also considered.
