13) Description of bird (size, shape, proportions, details of both color and pattern on head, back, chin, throat, breast, flanks, wings, undertail, and tail, etc.; coloration of soft parts: bill, legs, and feet) include only details actually seen in the field :	Small, thrush-type bird. Pale female-type plumage (pale gray undersides, pale blue-gray wash on back, pale blue flight feathers on wings and tail), white eyering, white undertail coverts. Solid color, unspotted breast.
14) Description of behavior:	Bird was moving around quite a bit when we first saw it at field east of A.E.Sea and north of Sea of Evanescence. It was sighted in various small trees, bushes and perched on low plants, sometimes only 1-3 feet above ground. Looked like it was hunting, apparently flycatching insects.
15) Description of vocalizations:	Heard only a couple of short vocalizations, songs. Vocalization assisted locating bird at one point.
16) Description of immediate and surrounding habitat(s):	Grassy field east of A.E.Sea and north of Sea of Evanescence, two small "lakes". Several clumps of trees and bushes of varying sizes, early spring vegetative debris (dead sticks from previous season's plants).

17) Optical equipment used for observation (type, power):	Swarovski EL 10 x 42 binoculars, Nikon Coolpix P600 zoom point-and-shoot camera
18) Distance/how measured?	Distances estimated. Viewed once from about 75 yards, once from about 50 yards.
19) Time of observation:	11:00 am
20) Total time of observation:	Photos are timed from 11:00am to 11:38am
21) Weather conditions:	Around 40-50F, wind gusty from the west at 15-20mph. No precipitation during observations. It felt cold.
22) Previous experience with this species and similar species:	I have seen this species in Rocky Mountain National Park several times. Have also viewed Western and Eastern Bluebirds in various locations, the latter often in both Cook and DuPage Counties in Illinois.
23) Please eliminate other similar species and/or hybrids:	No rufous seen on this bird at all.

26) Books and illustrations consulted and advice received. How did these influence this description?:	David Sibley's book The Sibley Guide to Birds published 2000. Bird looked most like illustration of Mountain Bluebird Gray Adult female.
