13) Description of bird (size, shape, proportions, details of both color and pattern on head, back, chin, throat, breast, flanks, wings, undertail, and tail, etc.; coloration of soft parts: bill, legs, and feet) include only details actually seen in the field:	Bird was a dark and shiny color with blueish tint too it. Had a light colored eye that I could see through the scope and also had a pretty large and droopy bill. Not straight that would suggest a Boat Tailed. And the bird was significantly larger than the surrounding Common Grackles. (Sorry I couldn't get any next to the bird in photo). Last, but not least the tail was enormous. I've seen Great-Tailed Grackle before in the Branson, Missouri Area, but dang was it a long and diamond shape tail. (Yes, it was). Longer tail and larger droopy bill suggest Great-Tailed Grackle without even getting into the range and likelihood of either of the species. Hope this helps you all out! Thanks and good birding!
14) Description of behavior:	Well the bird didn't do a whole lot in the time of me watching, but it did stick around and seem very comfortable while Gary, William and I observed it. It did fly off and perform a circle figure then land back in the same spot though.

15) Description of vocalizations:	Never heard the bird. It was at a distance at which I could not hear. (Across a open shrub land and across small quarry pond). Essex Area is littered with these small estuaries.
16) Description of immediate and surrounding habitat(s):	Cattails, Phragmites (Common Reed), freshwater ponds, coal mining mounds developed from years of coal mining and piling of sediment.
17) Optical equipment used for observation (type, power):	Bushnell Elite Spotting Scope. 80mm, 20-60x eyepiece. Bushnell elite 10x42 binocs.
18) Distance/how measured?	175 yards. Educated guess from shooting at rifle ranges.

21) Weather conditions:	Clear sky, sunny and winds at 9mph out of southwest.
22) Previous experience with this species and similar species:	Experienced this species in Branson, Missouri area and in Oklahoma before. Experienced Boat-Tailed Grackle in Orlando, Florida and Everglades National Park.
23) Please eliminate other similar species and/or hybrids:	Common Grackle is eliminated due to head size to the body size and bill size to the head size comparison. Bill shape as well as size eliminates Boat-Tail. Tail length eliminates both. Range and probability pretty much eliminates Boat-Tail if we even want to start factoring that in.
