14) Description of behavior:	Feeding in trees in SE corner of Montrose Bird Sanctuary in a mixed flock with Black-throated Greens and America Redstarts; popping in and out of foliage
15) Description of vocalizations:	None

16) Description of immediate and surrounding habitat(s):	In trees close to the periphery of the "Forbidden Zone" at the SE corner of Montrose
17) Optical equipment used for observation (type, power):	Canon 7d Mark II with a 150-600 mm Sigma lens at full extension

26) Books and illustrations consulted and advice received. How did these influence this description?:	We did the Merlin Bird App Photo ID, and it identified the bird as a Townsend's. We texted the photo to Mike Carroll who we ran into when leaving and asked if he knew what it was. He showed the photo to other birders at Montrose (don't know who) who confirmed it was a Townsend's. We got home and looked in an Eastern Warblers guide and didn't see any possible matches. We looked in our Stokes Birds guide and at eBird, which confirmed the bird was indeed a Townsend's, at least in our minds. We then posted the bird to IBET and the Illinois Birding Network and Chicago Audubon Facebook Groups for confirmation.


