13) Description of bird (size, shape, proportions, details of both color and pattern on head, back, chin, throat, breast, flanks, wings, undertail, and tail, etc.; coloration of soft parts: bill, legs, and feet) include only details actually seen in the field:	Dainty gull compared to surrounding Herring Gulls. Black legs and slim, shorter, black bill. The wings were black at the very tips and extended slightly past the short, black-ipped tail. The underside and chest of the bird as well as the edges of the tail feathers appeared clean white. The head was clear and unstreaked, with a partial, smudgy,, dark hood that included the eyes except for a white crescent which joined at the rear of the eye. The back was gray, the wings gray-brown, and the nape clear. The smalle slender (and not drooping) bill, clear nape and chest, smaller overall size, and the brownish wings compared to gray back separated this bird from Laughing Gull.
14) Description of behavior:	The bird was sitting on the ice at the edge of some open water in the lake. It was about 150 yards away. Most of the time, it had its head tucked into its left wing, sleeping. A few times, it would raise its head for a few moments to allow me the opportunity to break down the field marks.
15) Description of vocalizations:	NA
16) Description of immediate and surrounding habitat(s):	Gages Lake is a small, suburban lake surrounded by houses. It was the only substantial open water in the CBC count area assigned to me.
17) Optical equipment used for observation (type, power):	Leica 77mm Spotting Scope
18) Distance/how measured?	Approximately 150 yards
19) Time of observation:	01:10 pm
20) Total time of observation:	Approximately 30 minutes
21) Weather conditions:	Initially, I found the bird in very light snow and low, gray skies. Within several minutes of finding the bird, the weather became much more extreme. Snow, mixed with light rain and ice became heavy.
22) Previous experience with this species and similar species:	I have seen many Franklin's Gulls at all ages. I have seen them in AZ, CC IL, TX, and WY.
23) Please eliminate other similar species and/or hybrids:	The smaller, slender (and not drooping) bill, clear nape and chest, smaller overall size, and the brownish wings compared to gray back separated thi bird from Laughing Gull.
